
- HVO to continue to provide the CCC with a monthly update on the HVO Continuation Project.





Safe Driving – gaining a reputation for the wrong reasons

A community complaint has been received about reckless driver behaviour from the evening of Wednesday 26 July near South Pit. It was reported a member of the public was tailgated and intimidated before the vehicle turned into our HVO South entrance.

This is the second complaint of reckless driving from our community this year. It's a reputation we don't want to have.

We share roads with our local community and unsafe habits impact them, reflect poorly on our business and put yourself at risk. This is a timely reminder to think twice before:

- Speeding (remember this is a limit, not a challenge), pulling out, and/or ignoring traffic signs on roads between HVO and your destination; or
- · Bullying / intimidating tailgating, beeping horn, flashing lights.

Your behaviour could result in a fine from the local police, have an impact on HVO's reputation / our future approval, or worse – you could injure yourself or others in a vehicle accident!

Given the potential reputational damage to HVO, disciplinary action may also be taken for offenders caught.

Local residents have contacted Singleton Highway Patrol regarding their concerns. If you see illegal or aggressive driving behaviours we encourage you to report this to the Police and your Supervisor.


Rehabilitation

- 10 ha seeded in 2023 (44 ha of new rehabilitation required).
- 30 ha shaped, 24 ha topsoiled
- Current work in Riverview and Cheshunt (Geofluv landform)
- 56 ha second stage rehabilitation seeded since start of 2023 including 4ha of hydroseeding completed at the SE TSF. 45 ha of GMD is scheduled for H2 2023 (97 ha required).
- Extensive maintenance works completed during H1 2023 based on 2022 rehab monitoring data. Focus on weed and Acacia Saligna management.

Weed Management 2023

Programme of activities 2023

- During 2023, weed management at HVO has primarily focussed within riparian areas along the Hunter River to manage the River Red Gum populations.
- The weeds focussed on include *Galenia pubescens*, *Pennisetum clandestinum* (Kikuyu) and *Ricinus communis* (Castor oil plant).
- In addition, HVO is making a concerted effort to minimise the establishment of Coolatai Grass on its lands to avoid the degradation of bushland and pasture areas. These have mainly required management along transport corridors such as Lemington Road.
- The accompanying figure shows the majority of areas where weed management has occurred at HVO during 2023.
- In addition, HVO has undertaken weed management within the biodiversity offsets.

Program of activities 2023

Synchronised baiting trapping programs coordinated with other sites and the Hunter Local Land Services (LLS).

- Summer and Autumn 1080 Wild Dog Control Programs completed
- Spring 1080 Wild Dog Control Program to commence 9th October 2023
- Autumn 'Hoggone' pig baiting program dates completed 7th June 2023
- Spring 'Hoggone' pig baiting program to commence 4th September 2023
- HVO rural licensee pig control programs are ongoing via bounty payments.

Kangaroo commercial harvests are currently impacted by the temporary closure of the Jerrys Plans chiller. We anticipate harvesting activities will surge once the chiller reopens

The site operates under an approved Environmental Management Strategy, and observations during the site inspection demonstrated good overall environmental management practices. The use of CMO Compliance Management Software (CMO) provides a robust and proactive approach to environmental management of the site.

Positive observations were noted with respect to air quality and noise management through the use of predictive met data and real time monitoring to implement controls suitable to changing conditions and activities. The use of aerial seeding was noted as a good initiative for the reduction of wind generated dust from stockpiles.

Substantial improvement to the surface water management system was noted with the implementation of the pipe burst detection system and water level monitoring on key water infrastructure. This provides assurance in the capture of offsite discharges, improved data inputs to the site water balance and enables better management of water volumes across site to reduce the chance of off-site discharges.

The rehabilitation program on site is very well organised, with robust systems to track aspects from the ground disturbance permit (GDP) process through to post rehabilitation monitoring. Areas not subject to active mining were being rehabilitated, with temporary seeding of inactive areas and stockpiles in place.

The CHPP, Workshops and other infrastructure were in good condition and well managed, with waste segregation, pollution controls and bunding in place and effective.

- Mammal surveys August to September












HVO Continuation Project

Project Disturbance Boundary

- Two scarred tress located within the Lemington Road realignment presented in the EIS were initially proposed to be impacted
- Further design review completed has resulted in the complete avoidance of impacts to these two sites
- No impact to any scarred trees as a result of the Project
- Additional work underway to minimise Project disturbance footprint in the vicinity of Site 12
- RTS to document revisions since EIS


