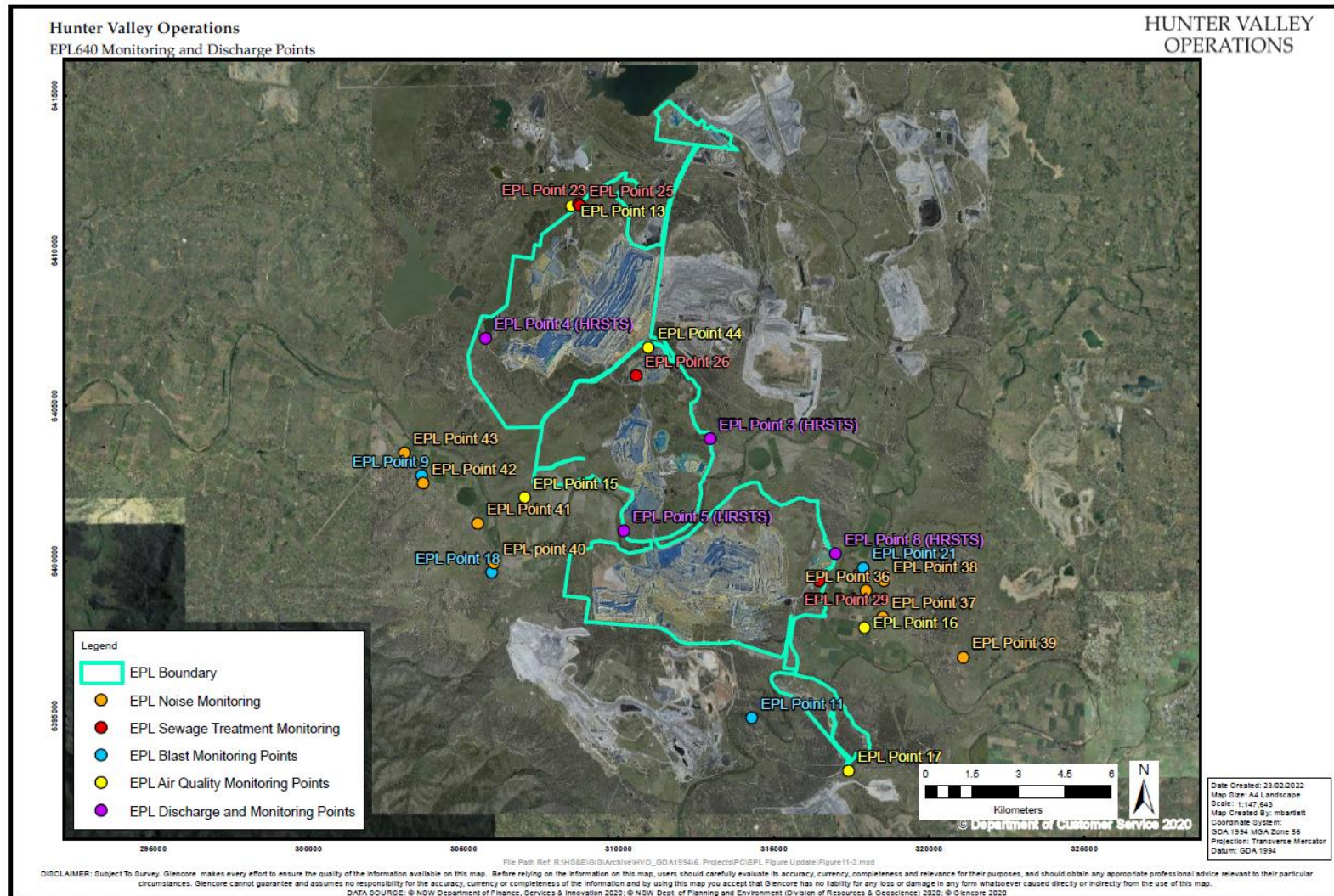
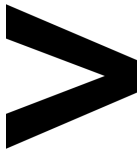
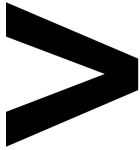


Figure 1: EPL 640 Monitoring Location
