One (1) community complaint regarding post-blast fume has been received to date during 2025.

25 March	3:40pm	Air quality	Community Hotline	N/A	<ul> <li>A resident of Jerrys Plains called the Community Complaints Hotline at 3:40pm regarding observed blast fume and concerns for health impacts.</li> <li>A member of the HVO environment and community team communicated with the resident via telephone confirming that a blast had been fired in the HVO Cheshunt Pit at 3:31pm. The team member provided feedback and information regarding the blast including mitigation measures and confirmation that the visible plume did not leave site boundaries.</li> <li>A subsequent phone call was received from NSW EPA at 9.17am 26 March 2025 regarding a complaint they received from a community member regarding the same blast. The EPA requested further information which HVO provided.</li> </ul>




Figure 2: 2025 Environmental Incidents by Type

Nine (9) environmental incidents with a Category 1 ranking have been reported to date during 2025. A summary of incident details are provided in **Figure 2** and **Table 2**.

#### Table 2: 2025 Environmental Incidents Detail

Date	Details	Key Actions	Aspect
6/01/2025	Oil leak at Newdell  Whilst coal hauling truck KH1026 was tipping coal at the Newdell dump hopper, the operator noticed oil leaking from the rear trailer. After investigation, a faulty hydraulic oil line on the trailer tilt ram was determined to be the cause. This resulted in approximately 30L of oil leaking to the sealed concrete surface beneath the truck	The trailer was lowered, leak sealed and hose replaced. The truck was moved in order to clean up the oil leak.  All contaminated materials were placed in designated oily rags bins and removed from site by the licenced waste contractor	Hydrocarbon
6/01/2025	HVAS PM10 dust exceedance – Cheshunt East Monitoring results indicate that on 6 January 2025, the Cheshunt East HVAS recorded a total result of 56.1µg/m3 for the 24-hour averaging period for PM10, exceeding the relevant criteria of 50ug/m3. An air specialist consultant was engaged to investigate the result and determined HVO's maximum possible contribution to be 22.8ug/m3	HVO implemented operational controls on 6 January to comply with the HVO Air Quality and Greenhouse Gas Management Plan. The Department of Planning Housing and Investment were advised of the exceedance on 18 November with an incident report submitted on 29 January. HVO notified affected residents as per requirements in HVO North Development Consent	Dust



21/01/2025	Oil spill at North workshop  After a maintainer had stopped transporting an oil pod from the oil pod storage / laydown facility to Bay N2 of the workshop, it was observed that the built-in oil pod bund was full of oil. After an investigation, it was found that oil had spilled from the bund during transport. Approximately 80L of oil spilled to both sealed and unsealed surfaces.	Contaminated soil materials were removed using a bobcat and transported to the Carrington bioremediation area	Hydrocarbon
28/01/2025	Oil leak at Newdell Train Load Out  An alarm alerted operators of a low oil level on the Newdell train power pack during the loading of a train. After investigation, it was identified that a loose fitting on the northern discharge gate of the TLO was leaking oil. This resulted in approximately 100L of oil leaking onto the mezzanine level as well as the ground surface below	Train loading was stopped, and the power pack was isolated, and accumulators bled prior to repair of the fitting.  Contaminated materials were removed by the licensed waste contractor using a vacuum truck and spill kits were replenished	Hydrocarbon
31/01/2025	Oil leak along Pikes Gully Road  An oil leak from a coal truck occurred on Pikes Gully Road between Newdell product stockpile and Howick CHPP. The leak of approximately 20L was detected by a truck operator in toe who notified the lead driver. The truck operator stopped the vehicle on the hard stand area and investigated the cause. The cause was found to be a failed hydraulic hose which was subsequently replaced.	The oil spill on the unsealed surfaces was removed using a scraper with contaminated materials transported and placed at Howick bio-remediation area.  The spilled oil along Pikes Gully Road was cleaned using absorbent material and a street sweeper	Hydrocarbon



1/03/2025	Kilburnie South HVAS PM10 Exceedance  Monitoring results indicate that on 1 March 2025, the Kilburnie South PM10 High Volume Air Sampler (HVAS) recorded a total result of 50.8µg/m3 for the 24-hour averaging period, exceeding the relevant criteria of 50ug/m3. No complaints were received on this day. An air specialist consultant was engaged to investigate the result and determined HVO's maximum potential contribution to be 9.7ug/m3 (HVO South) and 0.0ug/m3 (HVO North)	HVO implemented operational controls on 1 March to comply with the HVO Air Quality and Greenhouse Gas Management Plan. The Department of Planning Housing and Investment (DPHI) were advised of this exceedance on 17 March and an incident report was submitted on 24 March. No further follow up has been requested from DPHI	Dust
19/03/2025	Oil Spill in Howick Workshop  While refuelling oil tanks on the 990 Service Cart Vehicle in the Howick Workshop, the shut off mechanism/valve failed to stop the flow of oil into the tank, causing approximately 30L of oil to overtop the tank and spill to ground	The faulty valve was repaired. Contaminated spill absorbent material was cleaned up and disposed of in nearby oil rag bins	Hydrocarbon
25/03/2025	Post blast fume emissions from P102BWF402 – South Pit Blast HVO initiated blast P102BWF402A in the Cheshunt Pit 1 at 3:21pm on 25 March 2025. Post initiation, fume was observed. Weather conditions throughout the day and immediately leading up to the blast were overcast with showers persisting. The wind speed and wind direction at the time of the blast was 6.4m/s and 115 degrees respectively. Blast fume travelled from the initiation point post ignition in a north westerly direction dispersing over HVO land	Observed fume was ranked Level 3B in accordance with the AEISG rating scale.  An internal investigation into the cause of the fume found that water contamination from higher than forecast rainfall impacted explosive integrity. There were holes that were visibly impacted by the wet weather so a sucker truck was organised to extract bulk product from the hole to re-establish a competent charge and minimise fume generation. The post blast fume was observed to move slowly across the HVO mining area in a Westerly direction and fully dissipate visibly while over HVO land is indicated pre-blast plume modelling and meteorological assessment. A summary of rainfall data recorded at HVO weather stations during 2025 is provided in **Figure 3** and **Table 3**.




Figure 2: 2025 HVO Rainfall Data
