HVO Joint Venture

- Effective 12.00pm Friday 4 May 2018, the HVO Joint Venture (JV) is jointly owned by Yancoal 51% and Glencore 49%
- The HVO JV will be jointly controlled by Yancoal and Glencore through a Joint-Venture Management Committee (JVMC), and managed by an independent management team to be appointed by the JVMC
- Glencore has nominated the HVO General Manager (Tony Galvin) and Yancoal nominated the HVO Financial Controller (Tim Slater)
- Glencore provides systems and operational support services to the HVO JV.


HVO South Modification 5 Update

- Planning to commence lifting the Cheshunt Dump in Quarter 3 2018 following approval of the Mine Operations Plan (MOP)




Truck Sound Attenuation

- 32 trucks scheduled for 2019






Unauthorised vegetation clearing

- On Thursday 12 April 2018 HVO identified that approximately 242 m2 vegetation had been cleared on mine owned land subject to PA 06_0261
- The clearing was identified to have been undertaken by a Telstra contractor (Decon Technologies) for the purpose of upgrading their facility adjacent to the clearing
- HVO did not provide authorisation for Telstra or any of its contractors to access this land or clear vegetation.






