





• Enforceable Undertaking with EPA (18-3-2019 incident)

HV Operations Pty Ltd undertakes to implement various environmental protection works in Singleton, NSW following discharge of sediment-laden water

HV Operations Pty Ltd (HVO) has entered into an enforceable undertaking with the NSW Environment Protection Authority (EPA) following a water pollution incident involving the runoff of sediment-laden water into Farrells Creek and the Hunter River, which is an alleged breach of the *Protection of the Environment Operations Act 1997*.


Heavy rainfall in March 2019 caused runoff from HVO's mining premises to enter Farrells Creek and the Hunter River. The EPA was immediately notified by HVO of this incident. As a result, HVO has proposed, and the EPA has accepted, an enforceable undertaking which requires it to implement various environmental protection works and activities at the premises in order to prevent similar incidents from occurring in the future.

The environmental protection works will include, amongst other things, an area remediation plan, paying a financial contribution to Hunter Local Land Services to undertake a project to improve Travelling Stock Reserves, and regular monitoring of historic rehabilitation areas.

HVO has published this notice in accordance with the enforceable undertaking.


Reporting, Exceedances, Inspections and Audits As

- Penalty Infringement Notice Resource Regulator
 - Relates to same incident (18-3-19) involved with the Enforceable Undertaking
 - HVO fined \$2500 for non-compliance with its Mining Operations Plan

Reporting, Exceedances, Inspections and Audits As

- Independent Environmental Audit Report submitted on 2 April and received confirmation from the DPIE on 30 April that the report has been accepted.
 - Conducted every 3 years, for the 3 year period.
 - Audits HVO's approvals including DA's, EPL, Water Licences, Management Plans, Mining Tenements
 - HVO has approximately 1900 obligations in these approvals
 - 28 non compliances recorded
 - 0 high risk
 - 1 moderate risk (related to water discharge incidents reported during the period)
 - 12 low risk
 - 15 administrative
 - HVO has responded to all findings and the report is on the website

Program of activities 2020

- Summer 1080 Wild dog/fox program commenced 29th January and concluded 13th March. Program extended from 2-3 weeks to 6 weeks to address re colonisation and trial greater use of 1080 canid ejectors.
- Kangaroo culling (commercial harvest ongoing).
- Open range shooting (on-going bounty system linked to commercial harvest program)

Synchronised baiting/trapping programs, targeting pigs, wild dogs foxes in conjunction with the LLS.

Autumn

- 1080 Wild dog/fox control program commenced 4th May 2020 (underway)
- Pig trapping program to commence 9th June 2020

Spring

• 1080 Wild dog/fox control program to commence 12th October 2020.
