




## Carrington – as at November now TSF






























### Feral pest management 2021

#### Program of activities 2021

- Kangaroo culling (commercial harvest ongoing).
- 7 Commercial Kangaroo harvests completed year to date 2021
- Open range shooting (on-going bounty system linked to commercial harvest program)

Synchronized baiting/trapping programs, targeting pigs, wild dogs and foxes in conjunction with the LLS. Dates confirmed at the Central Hunter Pest Managers Meeting

#### Summer (complete)

 1080 Wild dog/fox control program to commenced 1st February 2021 and completed 19th February 2021.

#### **Autumn (complete)**

- LLS dog trapping program conducted at HVO across buffer properties by Volker Dreyer from the 1<sup>st</sup> to the 15<sup>th</sup> April traps bait shy animals including 3 foxes and 5 dogs
- 1080 Wild dog/fox control program to commence on the 17<sup>th</sup> May 2021 and conclude on the 11 June.

#### Winter

 Hog—eye pig trapping program to commence June/July 2021 following conclusion of the Autumn 1080 Wild dog/fox control program

#### Spring

1080 Wild dog/fox control program timed to commence on the 4<sup>th</sup> October 2021

## Heritage

#### Activities undertaken in previous quarter:

Reinstatement of security boarding at Chain of Ponds Inn completed

#### **Proposed activities:**

- Archerfield Stables structural works (Q3)
- Planning for temporary onsite storage of Archerfield agricultural heritage items while repair/preservation works at the Archerfield Stables.
- Vegetation maintenance work around the Cockatoo Fence planned for June 2021 ahead of a photo archival recording
- Yard maintenance works and Termite Interception System inspections at LEP listed properties ongoing.





# Reporting, Exceedances and Inspections

- Annual Review submitted to DPIE on 1 April
- Resource Regulator Targeted Assessment Program on rehabilitated landforms. Inspection held 30 March. Follow up inspection to be held 25 May
- Incident notifications submitted to DPIE and EPA for technical noncompliances during Hunter River Salinity Discharge Scheme
  - Electrical conductivity not continuous for a short period
  - Total Suspended Solids exceedance
  - Flow measurement inaccuracy for a short period
- Incident report for Dam 2N sediment dam overtop during extended rainfall in March. Submitted to DPIE, EPA and Resource Regulator


# Reporting, Exceedances and Inspections

- Submitted Annual Report on progress of Enforceable Undertaking for the East TSF to EPA in February
- Submitted Annual Analysis report on the performance of seepage management actions for the North Void TSF in March to EPA
- Revised Mining Operations Plan submitted to Resource Regulator in March
- National Pollutant Inventory (NPI) submitted to EPA in March
- DPIE aerial surveillance conducted 18 April, no issues identified

### HVO Continuation Project – Update

- ✓ Secretary's Environmental Assessment Requirements (SEARs) received from DPIE on 11<sup>th</sup> March
  - Technical studies to support the EIS are well underway, with a number of draft reports under review
  - EIS lodgement targeted for Q3/4 this year
- Application for Site Verification Certificate (SVC) approved by EES on 28<sup>th</sup> April
  - Verifies no strategic agricultural land in proposed mining areas
- Project referral to the Commonwealth Department of Agriculture, Water and Environment (DAWE) in preparation for lodgment this quarter
- Proposing to undertake further community consultation to discuss outcomes of technical studies and seek input into Social Impact Assessment
  - Project newsletter #2 to be distributed in coming days
  - Community Info Days (Maison Dieu and Jerrys Plains) in June
  - One-on-one interviews with interested community members

#### Newsletters

Newsletters and surveys were distributed via letterbox drop to residents of Jerrys Plains, Long Point, Camberwell and Maison Dieu.



#### **Community Surveys**

A community survey was circulated to help us understand key Project issues. A total of 103 responses to the survey were received, including:

- 50 responses from local residents;
- · 6 responses from the broader area; and
- · 46 responses from interstate and overseas.

# HVO South Minor Modification - ANE Facility

- Modification of existing consent (PA 06\_0261) to allow for the construction and operation of a modular Ammonium Nitrate Emulsion (ANE) manufacturing plant within the existing approved HVO South mine disturbance area.
- A Statement of Environmental Effects (SSE) to support the Proposed Modification is currently in preparation and assesses the potential impacts of the proposed modification on environmental aspects such as Traffic and Transport, Surface Water, Air Quality, Noise, Hazards and Dangerous Goods and Greenhouse Gas and Energy. None of these aspects has been assessed as increasing any environmental or public impacts.
- HVO has identified two proposed locations within the currently approved HVO South project boundary


# Ammonium Nitrate Emulsion (ANE)



ANE is classified by the *Australian Dangerous Goods Code* (2020) as an oxidiser, requiring combination with initiators to become an explosive.

ANE is used by HVO and various other operations in the Hunter Valley to waterproof explosives in wet conditions, and also assists in minimisation of blast fume.


# **ANE** Facility

- Location A is an existing hardstand area at HVO South operations, which currently includes the existing approved AN and ANE storage and distribution facilities
- Location B is also within the approved disturbance area for the HVO South operations. Location B is represented by a region such that the facility could be located anywhere within that region.



#### HVO South Minor Modification - Lemington Underground Water Storage

- HVO and MTW are investigating ways to improve site water management across the operations.
- Currently assessing feasibility of storage of site water in the former Lemington Underground Mine workings.
- This would involve installing additional bores to transfer water into, and extract water from, the Lemington Underground Mine workings
- Works would be undertaken within existing disturbance areas.
- Modification of existing HVO South Project Approval and Warkworth Development Consent would be required.



#### EL5606 and EL8821

• Four drillsites (not five drillsites as previously reported) on EL5606 and the underlying EL8821 are proposed for 2021.
